Foresters looking for improved pine control when making site-prep applications have found an answer in Milestone and Capstone specialty herbicides. Research and operational results have shown that tank mixtures of Milestone + Accord® XRT II or Capstone + Accord XRT II improve the consistency and level of pine control achieved in site preparation treatments versus glyphosate only treatments. From May through July, Dow AgroSciences recommends a rate of 6 quarts Accord XRT II + 7 fluid ounces of Milestone per acre be applied for control of southern yellow pines. For sites that have Virginia pine, Dow AgroSciences recommends 1 gallon of Accord XRT II + 1 gallon of Capstone per acre and apply the treatment anytime from May – October. From August through October, Dow AgroSciences recommends a mixture of 1 gallon Accord XRT II + 1 gallon Capstone per acre for late season southern yellow pine control.

- Active ingredients: aminopyralid and triclopyr amine
- Essential tank mix partner with Accord XRT II for late season southern and Virginia pine and cedar control
